The Australian Horticultural Exporters' Association Inc. [AHEA] on behalf of the Japan Citrus Management Committee [JCMC] will again coordinate the cold disinfestation Inspections for citrus exported to Japan for the 2006 season, which is expected to start **commencing 7<sup>th</sup> June 2006**.

Exporters should register their interest in participating in the 2005 season **no later than 4.00pm Wednesday May 3<sup>rd</sup> 2006** on the application form attached.

Again a Participation deposit will be required and has been held at **\$5500.00 incl. GST**.

Fruit presented for pre shipment inspection by the Japan MAFF inspector will be further invoiced to the Exporter on a weekly basis at a 0.55 cent levy rate per standard 18kg carton inspected, or pro rata as per the agreement.

Before commencement of the season, all participants must further agree to conditions of access to the Inspector by signing an agreement for inspection of citrus fruit for export with the AHEA, through its service company, Australian Horticulture Export Import Services ( AHEIS).
